Most of you might not know that the only neighborhood that has a recent neighborhood plan that has been placed into effect is the West Salem neighborhood. This past and present year Morningside has been given the green light to finish our neighborhood plan. The Morningside board with your comments and ideas will go before the Planning Commission and the City Council to hopefully have them vote our plan into place. With our plan in effect we will have a neighborhood that is a livable and vibrant part of the State Capitol.

Another activity that has taken a hold in Morningside is the Community Emergency Response Team. Otherwise known as CERT, we have over twenty members and are always looking for more volunteers to become part of the team. We will be out there when the disaster hits. CERT members have been trained in controlling shock, putting out small fires, team building, disaster psychology and can respond within the neighborhood. We will be in green vests and hats. If the roads are not drivable CERT will be the people to contact. Morningside Methodist Church has given CERT the green light to place a 10'x20' metal box that will have some supplies kept in it. They are also a Red Cross disaster center. With that in mind, when a disaster happens, head to Morningside Methodist Church. Roger is part of the Salem Fire Department and is Emergency Preparedness Manager.

## SPEED LIMIT CHANGE ON PRINGLE ROAD

In February 2011, Morningside Neighborhood Association asked staff to pursue changing the speed limit on the section of Pringle Rd that is currently 25, to 30 mph (between Madrona Ave and Copper Glen Dr). City staff submitted the speed limit change request to the Oregon Department of Transportation (ODOT) for their review and recommendation. ODOT determines all speed limits in Oregon, even in Cities and Counties. After completing their study of Pringle Rd, ODOT agreed to recommend changing the speed limit. The City will be posting 30 mph signs in April or early May.

### PROPOSED BYLAW CHANGES

Due to proposed City budget reductions that eliminate printing and mailing of future newsletters, the following bylaw change is being proposed. Proposed deletions are struck out. The proposed addition is in bold and italics.

#### ARTICLE III MEMBERSHIP

##### Section 2. Voting

There shall be no voting by proxy. Each Executive Board Member of legal voting age shall be entitled to one vote at any meeting at which that Member signs the register.

***Board votes not on meeting nights may be by e-mail, fax, mail, or telephone. All members shall have a chance to participate. A quorum of the whole board is required to approve. Such action must be ratified at the next board meeting.***

#### ARTICLE VII: MEETINGS

##### Section I. Board Meetings

- b. *Special Meetings:* Special meetings of the Board may be called by the Chairperson, or, if he or she is absent, by the Vice Chairperson or by the Secretary. Notice of time and place of any special Board meeting shall be given to each Board member, ~~either personally or by mail,~~ at least 48 hours prior to such meeting. The notice shall state the purpose of the meeting.

#### ARTICLE VIII: AMENDMENTS

These bylaws may be repealed or amended or new bylaws may be adopted by a majority vote of general members of legal voting age at any general membership meeting. ~~Written notice of the meeting and of the proposed bylaw changes shall be forwarded to all members at least ten days prior to the meeting.~~
